Sub : **Consultant for Promotion and Public Outreach Program for BRTS in Pune**

Dear Sir,

During our meeting on 20th July 2015, a specific mention was made on the above mentioned subject since NCM was given to believe during the site visit conducted for NGOs on 18th July 2015 that the Promotion and Public Outreach Program by the Consultant IBI-CEE jointly would cover only Sangamwadi - Alandi Road – Nagar Road corridors.

Hence we would like to stress and put on record that PoP must cover the Pilot BRTS project also since a lot of negative perception exists in the minds of commuters and all citizens like.

Over and above that, the following words leaves no space for ambiguity on coverage area :

- A. Tender & Bid Process documents with instructions for “consultancy services for promotion and outreach program for **BRTS in Pune**. This term is stated at numerous places but specifically under following :
 1. Under Appendix A
 2. Under Preamble
 3. Under 3.3
 4. Under 4 (General condition of Contract)
- B. In addition, technical & price bid submitted by IBI Consultancy India Pvt. Ltd. dated 14.01.2015 states “With respect to tender for the promotion and outreach program for Bus Rapid Transit System (**BRTS**) in **Pune City**”.
- C. Financial bid document for Rs. 94,41,049 from IBI (undated) states “ covers consultancy services for promotion and outreach for **BRT in Pune City**”.
- D. **With regards anomaly on dates as it seems that PMC is confused**
 - 3.4 under time limit for completion of work states “**six months including monsoons and will be counted from date of issue of work order**”
 - 4.2.2 states “**consultant will begin services from date of issue of work order**”
 - PMC issued work order on **25.02.2015** which was received by Mr. Kulkarni on 02.03.2015 signed but without company stamp (which he states he did not have in Pune ??)
 - Yet as per news reports agreement between IBI and PMC was signed **mid July 2015**

In case the consultant is covering only Phase-1 corridor and not Pilot Project, then we believe that commitment for payment by PMC must be reduced by half. All above points need to be sorted out at the earliest. We await your clarification.
