Major Achievements

PCI Inquiry:

It was reported in the NCM activities of the year 2010-11 that Nagrik Chetna Manch and Surajya Sangharsha Samiti came forward to establish a People's Commission of Inquiry (PCI) with Justice P. B. Sawant, retired Supreme Court Judge as the chair to solicit complaints from the citizens regarding encroachments, unauthorised constructions, blocking the course of natural water bodies, occupation without CC/OC and other illegalities.

Subsequent action on the above took place during the FY 2011-12 for which we did get cooperation from the PMC for a little while. The Terms of Reference for the PCI covered:

- Illegal Buildings and Encroachments.
- Diversion of the flow of natural water bodies.
- Occupation without completion/occupation certificate.
- Slippages in the implementation of the Development Plan.
- Failure of Administration and of PMC staff.
- Solutions and reforms.

PCI had hearings during the year 2011 on which Mr. Justice P. B. Sawant gave his orders. We had issued notices to the complainants, offending parties and PMC (Commissioner and Additional City Engineer).

The PCI selected only those complaints where the complainants produced documentary evidence of the irregularities. Further, the PCI insisted that the complainants or their representatives be present at the hearings. Hon'ble Justice (retired) P. B. Sawant heard the parties at the hearings, weighed the evidence and either pronounced his judgement or adjourned the hearings for a future date to allow production of complete evidence or to ensure attendance of key parties. Where parties did not attend, Hon'ble Justice (Retd) Mr. Sawant gave his orders ex parte, after giving adequate opportunity for the parties to be present.

It is important to note that PMC has not yet displayed detailed list of illegal constructions on PMC's website. These are in thousands and are causing great social trauma to the citizens and lowering their

quality of life. Similar is the case with occupation of premises without occupation certificates, which has deprived a number of citizens of drinking water from the PMC and affected their health because of total lack of drainage facilities for sewage.

We note with great satisfaction that the staff at the PMC have acted on many of the judgments given by Hon'ble Justice Mr. P. B. Sawant and have removed unauthorised constructions till the time Mr. Mahesh Zagade was the PMC Commssioner. Subsequently actions on all these suddenly cooled down.

It is also important to note that because of the judgment of the PCI, all the aggrieved parties now have a very clear option for approaching the Hon'ble Bombay High Court for redressal. Further details of this will be covered in the President's address.

NCM also initiated various RTI applications for which a student of XIME, Mr. Pathak Shantanu Niteen volunteered and worked very hard in filing the applications. Further details of this will be covered in the President's address.

PILs:

Besides the above **NCM** had also launched a number of PILs, e.g. TDR, BB-Paud Road, pleasure trips to Vaishno Devi and Darjeeling. The President will provide the latest updates on all the court cases in his address.
