Open Session

During the open session, members gave their suggestions for new topics that the Manch could take up going ahead and volunteered to participate. This was greatly appreciated as Convenors were immediately appointed along with their teams.

Programs Conducted during the FY 2014-15:

NCM conducted an interaction with Commissioner of Police, Mr. Satish Mathur on 12th November 2014 at the Poona Club. The event was well attended and widely covered by the local media.

Meetings & interactions with PMC and other government officials:

During the year NCM had innumerable meetings with officials of PMC and many other authorities. The Secretary will provide the details in her address.

1. Issues taken up and are ongoing :

- i) Speed-breakers – in communication with IRC to know actual codes which must be implemented
- ii) BRTS – NCM calls it 'modified transport system'. Through frequent interaction and site visit, endeavour has been to push it towards the actual concept as much as possible.
- iii) Objections to wide spread decrease of green cover, cutting / transplanting of trees.
- iv) Communication with NITI Aayog on PMC's mis-representation on MSW situation in Pune and giving true picture. This has prompted NITI Aayog to question Maharashtra State UDD for a response.
- v) On the deteriorating MSW situation with no end in site as PMC was not following the MSW 2000 Rules, NCM sent sou moto letter to Bombay HC. It reached the Hon'ble bench on the day that an earlier PIL was slotted to be heard. In that day's order, Hon'ble bench recorded that NCM should be asked to depose and file an affidavit given the seriousness of the data submitted which was contrary to PMC's claims. On the next date of hearing, not only did NCM submit an affidavit but also CA 135 of 2015 so that we could continue to be heard along with PIL 70 of 2014.
